- 1. PROMOTION PERIOD:** The Promotion begins on May 1, 2021 at 12:00 AM (midnight) Eastern Time ("ET") and ends on July 31, 2021 at 11:59:59 PM ET ("Promotion Period"). The Promotion Period consists of three (3) phases ("Phases") as outlined in the chart below:

Win times for each Phase (as described below) will not carry forward into subsequent Phases. The Administrator's computer is the Promotion's official clock.

- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Officers, directors and employees of Pepsi Cola Company, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. B. Without a Purchase:

i. Mail-in Code Request: To obtain a Code without making a purchase from April 16, 2021 through July 16, 2021, an entrant may legibly hand write their full name (no initials), complete street address (no P.O. Box), age, and valid e-mail address on a 3½” x 5” properly stamped postcard and mail it (in an outer mailing envelope) with sufficient postage to: The Let’s Summer! Administrator will send one (1) Code per Mail-In Request by e-mail to the e-mail address provided on the request. There is a limit of one (1) Mail-in Requests per outer-mailing envelope per day during the Promotion Period. Multiple mail-in requests with the same postmark date will be deemed one (1) request. Mail-in requests will not be returned and no further correspondence will be entered into. Mail-in requests must be original and hand-written. No mechanical reproductions are allowed.

ii. Online Code Request: To obtain a Code without making a purchase from 12:00 AM ET on July 17, 2021 to 11:59:59 PM ET on July 31, 2021, an entrant may use the Code 184542372022.

During the Promotion Period, after an entrant has obtained a Code, entrants must visit www.chipsnips.com (“Website”) and enter his/her e-mail address. An entrant must then follow the on-screen instructions to register by providing the information requested by Sponsor including, but not limited to, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, date of birth, and confirmation entrant has read and agrees to be bound by these Official Rules. Entrant must then select prize he/she wants to play for from among the available prizes for the respective Phase. Entrant must then follow the on-screen prompts to submit their Code. After completing the registration form, an entrant will receive one (1) game play (“Game Play”). After a valid Game Play, the entrant will receive an on-screen notification indicating whether he/she is a potential Instant Win Game prize winner (“Notification”). B. Total ARV: The total ARV of all available prizes in the Promotion is \$45,867.95.
