OFFICIAL RULES

The Let's Summer! Get Ready For Adventure (North Division) Promotion ("Promotion") is sponsored by Pepsi-Cola Company ("Sponsor"), 1111 Westchester Avenue, White Plains, NY 10604 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Promotion begins on May 14, 2021 at 12:00 AM (midnight) Eastern Time ("ET") and ends on July 31, 2021 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion's official clock.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of Connecticut, Delaware, Indiana, Kentucky, Maine, Massachusetts, Michigan, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, and Vermont ("Eligibility Area"), who are at least eighteen (18) years old at the time of entry. Officers, directors and employees of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. B. Without a Purchase:

i. Mail-in Code Request: To obtain a Code without making a purchase from May 1, 2021 through July 16, 2021, an entrant may legibly hand write their full name (no initials), complete street address (no P.O. Box), age, and valid e-mail address on a 3½” x 5” properly stamped postcard and mail it to: The Let’s Summer! Get Ready For Adventure (North Division) Promotion Code Request, P.O. Box 490, Southfield, MI 48037. Mail-in requests must be postmarked by July 16, 2021 and received by July 26, 2021. Administrator will send one (1) Code per Mail-In Request by e-mail to the e-mail address provided on the request. There is a limit of one (1) Mail-in Requests per day during the Promotion Period. Multiple mail-in requests with the same postmark date will be deemed one (1) request. Mail-in requests will not be returned and no further correspondence will be entered into. Mail-in requests must be original and hand-written. No mechanical reproductions are allowed.

ii. Online Code Request: To obtain a Code without making a purchase from 12:00 AM ET on July 17, 2021 to 11:59:59 PM ET on July 31, 2021, an entrant may use the Code 184542372022.

During the Promotion Period, after an entrant has obtained a Code, entrants must visit Chipsnsips.com/north (“Website”) and enter his/her e-mail address. An entrant must then follow the on-screen instructions to register by providing the information requested by Sponsor including, but not limited to, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, date of birth, and confirmation that entrant has read and agrees to be bound by these Official Rules. Entrant will be playing for a chance to win specific prizes based on his/her ZIP code. **Each group of ZIP codes is a different pool (“Pool”) and each Pool will have select prizes available. [Click here](#) for list of Zip Codes and prize Pools. The “General” Pool” is for all eligible entrants, regardless of ZIP Code. Some ZIP Codes may be in more than one (1) Pool.**

Entrant must then follow the on-screen prompts to submit their Code. After completing the registration form, an entrant will receive one (1) game play (“Game Play”). B. Total ARV: The total ARV of all available prizes in the Promotion is \$68,353.88.

C. Odds of Winning/Limit: The odds of winning a prize depend on when the entrant completes a Game Play. Prizes will be made available at random times throughout the Promotion Period.
